EXPLANATORY NOTE

WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan has received a request for reclassification of lot with an area of Forty Three Thousand Three Hundred Eighty Seven square meters (4.3387 has.) more or less, owned by Ms. Marissa Orallo, Ms. Lilian Orallo and Ms. Amelia Orallo represented by Mr. Norman Orallo, situated at Barangay Dupac, Asingan, Pangasinan covered under TCT Number 30310 from Agricultural land to Residential use;

WHEREAS, Section 20 (a) of Republic Act Number 7160, otherwise known as the Local Government Code of 1991 provides authority for a city or municipality through an ordinance passed by the Sanggunian after conducting public hearing for the purpose to reclassify agricultural lands and provides for the manner of their utilization or disposition;

WHEREAS, based on the Comprehensive Land Use Plan of the Municipality, the Municipal Planning and Development Coordinator has certified that the area concerned is categorized as agricultural thus reclassification is necessary;

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

ORDINANCE NO. 1 SERIES 2024

AN ORDINANCE RECLASSIFYING FORTY THREE THOUSAND THREE HUNDRED EIGHTY SEVEN SQUARE METERS (4.3387 HAS.) MORE OR LESS, OWNED BY MS. MARISSA ORALLO, MS. LILIAN ORALLO AND MS. AMELIA ORALLO REPRESENTED BY MR. NORMAN ORALLO, SITUATED AT BARANGAY DUPAC, ASINGAN, PANGASINAN COVERED UNDER TCT NUMBER 30310 FROM AGRICULTURAL LAND TO RESIDENTIAL USE

Section 1. Title – This ordinance shall be known as "An ordinance reclassifying Forty Three Thousand Three Hundred Eighty Seven square meters (4.3387 has.) more or less, owned by Ms. Marissa Orallo, Ms. Lilian Orallo and Ms. Amelia Orallo represented by Mr. Norman Orallo, situated at Barangay Dupac, Asingan, Pangasinan covered under TCT Number 30310 from Agricultural land to Residential use".

Section 2. Scope and Limitation – This reclassification specified therein shall apply to the Forty Three Thousand Three Hundred Eighty Seven square meters (4.3387 has.) more or less situated at Barangay Dupac, Asingan, Pangasinan covered under TCT Number 30310 more specifically described as follows:

 TCT Number 30310 with an area of Forty Three Thousand Three Hundred Eighty Seven square meters (4.3387 has.) more or less, owned by Ms. Marissa Orallo, Ms. Lilian Orallo and Ms. Amelia Orallo covered under Tax Declaration Number 05-0014-01419 of the Register of Deeds for the Province of Pangasinan.

Section 3. Repealing Clause. All Ordinances, resolutions, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity. This Ordinance shall take effect after proper posting and publication in a newspaper of general circulation.
