EXPLANATORY NOTE

WHEREAS, Section 497 (a) (2) (v) of the Local Government Code of 1991 provides that the Sangguniang Bayan shall prohibit the sale or dispensing of any intoxicating liquors at any retail outlet;

WHEREAS, there is a need to ban the selling and buying of any intoxicating liquor in the Municipality of Asingan from 10 o'clock in the evening to 7 o'clock in the morning.

NOW THEREFORE, on motion of SB Member Johnny Mar A. Carig, duly seconded by SB Members Athena Ira G. Chua, Marivic S. Robeniol and Julio P. Dayag, it was,

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

**ORDINANCE NO. 10
SERIES 2023**

AN ORDINANCE REGULATING THE SALE OR DISPENSATION AND EXCESSIVE DRINKING OF ANY KIND OF INTOXICATING LIQUOR OR WINE INCLUDING BEER IN PUBLIC PLACES INCLUDING RESTAURANTS, STORES AND SARI-SARI STORE REGARDLESS OF AGE THAT EXHIBITS UNRULINESS FROM 10:00 O'CLOCK IN THE EVENING TO 7:00 O'CLOCK IN THE MORNING AND PROVIDING PENALTIES FOR VIOLATION THEREOF

Be it enacted by the Sangguniang Bayan of Asingan, Pangasinan in session assembled that:

Section 1. Title. This Ordinance shall be known as "An Ordinance regulating the sale or dispensation and excessive drinking of any kind of intoxicating liquor or wine including beer in public places including restaurants, stores and sari-sari stores regardless of age that exhibits unruliness from 10:00 o'clock in the evening to 7:00 o'clock in the morning and providing penalties for violation thereof";

Section 2. Excessive drinking that exhibits unruliness means disorderly, not easily managed, controlled or disciplined, breaks the law or acts in a way that endangers others;

Section 3. Stores selling intoxicating liquor products must post a notice that "sale/distribution to or purchased of any intoxicating liquors are strictly prohibited" from 10:00 o'clock in the evening to 7:00 o'clock in the morning.

Section 4. Stores are also prohibited from selling any intoxicating liquors within one hundred meters (100 m) away from school, playground or other facilities frequent by minors.

Section 5. Minors are those below 18 years old of age are strictly prohibited from buying and/or drinking intoxicating liquors.

Section 6. Drinking of any intoxicating liquors in front of retail stores within the territorial jurisdiction of this Municipality is strictly prohibited.

ARTICLE I. ADMINISTRATIVE PROVISIONS

Section 1. The Office of the Municipal Mayor through the assistance of the Asingan PNP as well as Barangay Officials of this municipality are hereby authorized to implement this ordinance.

Section 2. The Office of the Municipal Mayor through the assistance of the local PNP as well as Barangay Officials shall also institute an appropriate and widest information dissemination to all concerned.

ARTICLE II. PENAL PROVISION

Section 1. Any person who shall violate, disobey, refuse or neglect to comply any of the provisions of this ordinance shall be punished with the following:

First Offense	One Thousand Pesos (Php1,000.00) fine
Second Offense	One Thousand Five Hundred Pesos (Php1,500.00) fine
Third Offense	Two Thousand Pesos (Php2,000.00) or an imprisonment for a period not exceeding six (6) months or both such fine and imprisonment at the discretion of the court

Section 2. Stores who will be caught selling of any intoxicating liquors shall be punished with the following:

First Offense	One Thousand Pesos (Php1,000.00) fine
Second Offense	One Thousand Five Hundred Pesos (Php1,500.00) fine
Third Offense	Two Thousand Pesos (Php2,000.00) or revocation of business permit or both at the discretion of the court

Any person apprehended for violation of this Ordinance who does not wish to contest the violation and is willing to pay voluntarily the penalty imposed upon him/her prior to the filing of formal complaint shall be allowed to pay said fine with the Treasurer's Office to avoid being prosecuted.

ARTICLE III. SEPARABILITY CLAUSE

In the event that any provision of this ordinance is declared invalid, the other provisions not affected thereby shall remain in full force and effect.

ARTICLE IV. REPEALING CLAUSE

All local laws, rules and regulations which inconsistent with this ordinance is hereby repealed or modified accordingly.




