EXPLANATORY NOTE

WHEREAS, Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991 states, "Every local government unit shall exercise the power expressly granted, those necessarily implied therefrom, as well as power necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare";

WHEREAS, there is an endeavor to integrate local health systems into province-wide health system, consisting of component city and municipal health systems, to ensure the effective and efficient delivery of population-based and individual-based health services, by virtue of Section 19 of Republic Act 11223, or the Universal Health Care (UHC) Act of 2019;

WHEREAS, the Sangguniang Panlalawigan of the Province of Pangasinan has issued Provincial Ordinance No. 328, series of 2024 entitled "An Ordinance Institutionalizing the Establishment and Operationalization of the Provincial Health System, including its Management Support Systems and Appropriating Funds Thereof" signifying its commitment and intent to operationalize and fully implement the integration of the local health system endeavored in the UHC Act;

WHEREAS, this body recognizes the importance to address health system fragmentation and to reorient the health systems toward primary health care, primarily through the integration of local health systems into province-wide health systems;

WHEREAS, the Municipality of Asingan, Pangasinan is firmly committed to supporting and implementing all local health systems reforms endeavored in the UHC Act, particularly related to health systems integration, the establishment and management of Special Health Fund, the shift to network-based contracting of health care providers, and to fulfill the activities, outputs, and outcomes for the success of integrated province-wide health systems;

NOW THEREFORE, on motion of SB Marivic S. Robeniol, duly seconded by SB Members Joselito V. Viray, Athena Ira G. Chua, Johnny Mar A. Carig and Mel F. Lopez, it was,

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

**ORDINANCE NO. 11
SERIES 2024**

AN ORDINANCE INSTITUTIONALIZING THE ESTABLISHMENT AND OPERATIONALIZATION OF THE PROVINCEWIDE HEALTH SYSTEM, INCLUDING ITS MANAGEMENT SUPPORT SYSTEMS AND APPROPRIATING FUNDS THEREOF

Section 1. Title. This ordinance shall be known as "An Ordinance institutionalizing the establishment and operationalization of the Provincewide Health System, including its Management Support Systems and Appropriating Funds thereof";

Section 2. Declaration of Policy. The Municipality of Asingan, Pangasinan shall adopt as part of its laws the approved Provincial Ordinance No. 3218-2024 signifying its commitment and recognizing the importance of integrating the management, delivery, and financing of health care services as a means to improve health outcomes and quality of life of their constituents. This body supports the integration of the Municipality of Asingan, into the name of the Pangasinan Province-Wide Health System (PPWHS) and shall be aligning its health plans, activities, and reforms incongruent with the implementation of the PWHS;

A copy of the said Provincial Ordinance (LGI KRA 3.1 is hereto attached as "Annex A" and made an integral part of this Asingan Ordinance.

Section 3. Objective. This ordinance shall seek to sustain and institutionalize the reforms initiated with the Province of Pangasinan establishing an integrated local health system, under the Universal Health Care (UHC) Act of 2019.

Section 4. Implementation Arrangement.

- a. The Municipality of Asingan through the Municipal Health Board shall implement this ordinance and other incidental activities thereto. The necessary guidelines, rules, and regulations for effectively implementing this ordinance may be formulated and issued as applicable.

- b. The Municipal Health Board, in addition to their roles and function provided in Section 102 (b) of the Local Government Code (LGC) of 1991, shall support and adhere to the organization and operations of the Province Health Care provider Network, specifically in the establishment of the Primary Care Provider Network (PCPN) and in sustaining the operations of the management support systems such as but not limited to:
1. Local Investment Plan for Health and its Annual Operational Plan
 2. Human Resources for health management and Development (HRHMD) System
 3. Information Management System
 4. Epidemiology and Surveillance System (ESS)
 5. Supply Chain Management System (SCMS)
 6. Patient Navigation and Referral System (PNRS)
 7. Disaster Risk Reduction and management in Health (DRRM-H) System
 8. Health Promotion Programs and Campaign (HPPC)
- c. The Municipal Health Office shall be the technical secretariat of the health board and shall be responsible for the technical and financial integration of the municipality to the province-wide health system.

Section 5. Appropriation. The funds necessary to carry out the provisions of this Ordinance shall be included in the 2024 Annual Budget in the amount of Twenty Three Million Eight Hundred Seventy Eight Thousand Nine Hundred Twenty Four Pesos and 65/100 (Php23,878,924.65) for RHU I and RHU II, and shall be increased in the subsequent years of implementation subject to the availability of funds.

Section 6. Separability Clause. If, for any reason, any part, section, or provision of this Ordinance is declared invalid and unconstitutional, the other parts, sections, or provisions not affected shall remain in full force and effect.

 Section 7. Repealing Clause. All prior ordinances, resolutions, executive orders, administrative orders, rules and regulations, or parts thereof that are contrary to or inconsistent with the provisions of this ordinance are hereby repealed, amended, or modified accordingly.

Section 8. Effective Clause. This ordinance shall take effect in accordance with the provision of Republic Act No. 7160, also known as the Local Government Code of 1991, as amended.
