EXPLANATORY NOTE

WHEREAS, Section 11, the State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost. There shall be priority for the needs of the underprivileged sick, elderly, disabled, women, and children. The State shall endeavor to provide free medical care to paupers;

WHEREAS, Section 2 (c) of Republic Act Number 7277, as amended by Republic Act Number 9442, otherwise known as the "magna Carta for Disabled Persons", provides that "the rehabilitation of disabled persons shall be the concern of the government in order to foster their capacity to attain a more meaningful productive and satisfying life. To reach out a greater number of disabled persons, the rehabilitation services and benefits shall be expanded beyond the traditional urban-based centers to community-based programs that will ensure the full participation of different sectors as supported by national and local government agencies;

WHEREAS, there is a need to establish a community-based rehabilitation program for children with special needs.

NOW THEREFORE, on motion of SB Member Marivic S. Robeniol, duly seconded by SB Members Joselito V. Viray, Julio P. Dayag, Melchor J. Cardinez, Sr., Athena Ira G. Chua, Johnny Mar A. Carig and Mel F. Lopez, it was,

Be it ordained by the Sangguniang Bayan of Asingan, Pangasinan in session assembled that:

Section 1. Title. This Ordinance shall be known as "An Ordinance providing for the Community-based Rehabilitation program for Children with Disability".

Section 2. Comprehensive Program for Children with the following service delivery network:

- a. Training of members of the Barangay Council for the Protection of Children (BCPC), women of reproductive age on the prevention of disabilities, identification of common developmental conditions, provision of proper care to children with disabilities and other relevant topics.
- b. Mapping of children with signs of common developmental conditions. To be spearheaded by the Asingan Municipal Health Office in coordination with the Barangay Council for the Protection of Children (Barangay Health Workers).
- c. Referral of children with signs of common developmental conditions to Stimulation Therapeutic Activity Center for initial assessment.
- d. Conduct a case study report and home visit to determine the child's eligibility to avail the service.

Section 3. Asingan Stimulation Activity Center Programs and Services.

- a. Evaluation and diagnosis of children with suspected or confirmed developmental disorders.
- b. Therapy Services:
 - ✓ Physical Therapy
 - ✓ Occupational Therapy
- c. Educational Services:
 - ✓ Provision of Basic Writing
 - ✓ Recommendation for placement to appropriate Special Education, mainstreaming or inclusion programs.
- d. Transfer of skills and knowledge to families/guardians of children with disabilities through the lectures conducted in relation to welfare of children with disability.
- e. Training for Physical Therapy in charge, Occupational Therapy in charge and other staff serving in Stimulation and Therapeutic Activity Center (STAC).
- f. Other services and program that will facilitate development of children with disability.
 - ✓ Conduct of Hydrotherapy, Halloween and Christmas Celebration, Family Day Celebration
- g. Medical, neurologist, psychiatrist check-up.
- h. Provision of medical and educational assistance:
 - ✓ Provision of Assistive Device
 - ✓ Dental Assessment

Section 4. Monitoring. The members of the BCPC shall monitor the implementation of the Comprehensive program for Children with Special needs and shall regularly submit reports and recommendations to the Municipal Mayor and the Municipal Social Welfare and Development Officer.

Section 5. Appropriation. The amount for the implementation of program shall be Seven Hundred Thousand Pesos (Php700,000.00).

Section 6. Repealing Clause. All Ordinances, resolutions, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.






