WHEREAS, the Sangguniang Bayan of Asingan, Pangasinan has received a request for reclassification of lot with an area of Twenty One Thousand Three Hundred Sixty One square meters (2.1361 has.) more or less, owned by Local Government Unit (LGU) of Asingan, Pangasinan represented by Municipal Mayor, Engr. Carlos F. Lopez, Jr., situated at Barangay Carosucan Norte, Asingan, Pangasinan covered under TCT Number 028 - 2021001194 from Agricultural land to Residential use (Pambansang Pabahay para sa Pilipino Program);

WHEREAS, Section 20 (a) of Republic Act Number 7160, otherwise known as the Local Government Code of 1991 provides authority for a city or municipality through an ordinance passed by the Sanggunian after conducting public hearing for the purpose to reclassify agricultural lands and provides for the manner of their utilization or disposition;

WHEREAS, based on the Comprehensive Land Use Plan of the Municipality, the Municipal Planning and Development Coordinator has certified that the area concerned is categorized as agricultural thus reclassification is necessary;

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

#### ORDINANCE NO. 18 SERIES 2023

AN ORDINANCE RECLASSIFYING TWENTY ONE THOUSAND THREE HUNDRED SIXTY ONE SQUARE METERS (2.1361 HAS.) MORE OR LESS, OWNED BY LOCAL GOVERNMENT UNIT (LGU) OF ASINGAN, PANGASINAN REPRESENTED BY MUNICIPAL MAYOR, ENGR. CARLOS F. LOPEZ, JR. AT BARANGAY CAROSUCAN NORTE, ASINGAN, PANGASINAN COVERED UNDER TCT NUMBER 028 – 2021001194 FROM AGRICULTURAL LAND TO RESIDENTIAL USE (PAMBANSANG PABAHAY PARA SA PILIPINO PROGRAM)

Section 1. Title – This ordinance shall be known as "An ordinance reclassifying Twenty One Thousand Three Hundred Sixty One square meters (2.1361 has.) more or less, owned by Local Government Unit (LGU) of Asingan, Pangasinan represented by Municipal Mayor, Engr. Carlos F. Lopez, Jr., situated at Barangay Carosucan Norte, Asingan, Pangasinan covered under TCT Number 028 - 2021001194 from Agricultural land to Residential use (Pambansang Pabahay para sa Pilipino Program)".

Section 2. Scope and Limitation – This reclassification specified therein shall apply to the Twenty One Thousand Three Hundred Sixty One square meters (2.1361 has.) more or less situated at Barangay Carosucan Norte, Asingan, Pangasinan covered under TCT Number 028 – 2021001194 more specifically described as follows:

 TCT Number 028 – 2022001908 with an area of Twenty One Thousand Three Hundred Sixty One square meters (2.1361 has.) more or less owned by Local Government Unit (LGU) of Asingan, Pangasinan covered under Tax Declaration Number 05 – 0010 – 02128 (Cad. Lot 7327-A) of the Register of Deeds for the Province of Pangasinan.

Section 3. Repealing Clause. All Ordinances, resolutions, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity. This Ordinance shall take effect after proper posting and publication in a newspaper of general circulation.
