NOW THEREFORE, on motion of SB Member Melchor J. Cardinez, Sr., duly seconded by all Sangguniang Bayan Members present, it was,

RESOLVED, as it is hereby resolved, to enact the following Ordinance, to wit:

ORDINANCE NO. 2 SERIES 2024

AN ORDINANCE GRANTING USUFRUCT TO THE REGIONAL TRIAL COURT, THREE HUNDRED SQUARE METERS (300 SQM.) LOT, PARTICULARLY LOT NUMBER 371 OF THE LGU LOCATED IN BETWEEN THE MCTC AND THE GRANDSTAND AT ASINGAN ATHLETIC GROUND, BARANGAY MACALONG, ASINGAN, PANGASINAN

Be it ordained and enacted, as it is hereby ordained and enacted by the Sangguniang Bayan of Asingan, Pangasinan in session assembled that:

Section I. TITLE. This ordinance shall be known as "AN ORDINANCE GRANTING USUFRUCT TO THE REGIONAL TRIAL COURT, THREE HUNDRED SQUARE METERS (300 SQM.) LOT, PARTICULARLY LOT NUMBER 371 OF THE LGU LOCATED IN BETWEEN THE MCTC AND THE GRANDSTAND AT ASINGAN ATHLETIC GROUND, BARANGAY MACALONG, ASINGAN, PANGASINAN";

Section II. DECLARATION OF POLICY. It is the policy of this municipality to lend its assistance to other government agencies which provide services for their constituents.

Section III. GRANT OF THE USUFRUCT. By virtue of this ordinance, the Regional Trial Court, Asingan, Pangasinan is granted usufruct over the three hundred square meters (300 sqm.) portion.

Section IV. CONDITION OF THE GRANT. The grant of the usufruct to Regional Trial Court, Asingan, is for the sole purpose of providing said entity with a place over and subject to the further condition that it will continue to provide efficient and effective service to its constituents and in violation hereof, the lot will automatically revert to the LGU;

Section V. REPEALING CLAUSE. All ordinances inconsistent with this ordinance shall be deemed repealed or modified accordingly.

Section VI. EFFECTIVITY. This ordinance will take effect upon immediately after favorable review by the Sangguniang Panlalawigan and requirements of posting and publication hereof shall have been complied with.
