EXPLANATORY NOTE

WHEREAS, pursuant to section 21 of the Local Government Code of 1991, it provides that Local Government Unit may temporarily close any national or local road, alley, park or square during fiesta celebration and to further regulate the use of above-stated street where recreation facilities, shopping areas, may be established and where goods, merchandise foodstuffs, commodities or articles of commerce may be sold and dispensed to the general public;

WHEREAS, during town fiesta celebration of Asingan, Pangasinan, the Public Plaza is used for the amusement activities and closing parts of the following streets for the "Baratilyo Caravan", half lane of Mayor's Boulevard (lane adjacent to the Plaza), half lane of P. Ramos Street (lane adjacent to the Plaza) and half lane of Millan Street (lane adjacent to the Plaza);

NOW THEREFORE, on motion of SB Member Melchor J. Cardinez, Sr., duly seconded by SB Members Marivic S. Robeniol, Athena Ira G. Chua, Johnny Mar A. Carig, Joselito V. Viray, Mel F. Lopez and Virgilio I. Amistad, it was,

AN ORDINANCE CLOSING THE HALF LANE OF MAYOR'S BOULEVARD (LANE ADJACENT TO THE PLAZA), HALF LANE OF P. RAMOS STREET (LANE ADJACENT TO THE PLAZA) AND HALF LANE OF MILLAN STREET (LANE ADJACENT TO THE PLAZA) TWO (2) MONTHS BEFORE AND EIGHT (8) DAYS AFTER TOWN FIESTA

Be it enacted by the Sangguniang Bayan of Asingan, Pangasinan in session assembled that:

Section 1. Half lane of Mayor's Boulevard (lane adjacent to the Plaza), half lane of P. Ramos Street (lane adjacent to the Plaza) and half lane of Millan Street, lane adjacent to the plaza shall be closed two (2) months before and eight (8) days after town fiesta.

Section 2. Closure of the afore-cited streets shall allow persons or entities to establish recreation facilities shopping areas for goods and merchandise, foodstuffs, commodities or articles of commerce.

Section 3. This Ordinance shall take effect after proper posting and/or publication as required by law.
