EXPLANATORY NOTE

WHEREAS, the Local Government Unit of Asingan, Pangasinan has constructed a building exclusively for the Sangguniang Bayan sometime 2016;

WHEREAS, the building was named Government Center which is adjacent to the Health Center (Rural Health Unit I);

WHEREAS, constituents often misconstrued that the Government Center is the Health Center:

WHEREAS, the Local Government Unit have decided to change the name of the building from GOVERNMENT CENTER to ASINGAN LEGISLATIVE BUILDING;

WHEREAS, under the guidelines on the naming and renaming of streets, public schools, plazas, building, bridges and other public structure paragraph 3., The Sanggunians of component cities and municipalities may, in consultation with the National Historical Institute, change the name of streets, roads, schools, health facilities or any other public place or building within its territorial jurisdiction (Sec. 13 of Local Government Code);

WHEREAS, in compliance with the aforequoted, the Sangguniang Bayan consulted the National Historical Commission and favorably agreed with the changing of the name of the building;

NOW THEREFORE, on motion of SB Member Joselito V. Viray, duly seconded by SB Members Athena Ira G. Chua and Marivic S. Robeniol, it was,

Be it resolved, as it is hereby resolved by the Sangguniang Bayan to enact the following Ordinance, to wit:

ORDINANCE NO. 3 SERIES 2025

AN ORDINANCE RENAMING THE GOVERNMENT CENTER TO ASINGAN LEGISLATIVE BUILDING OF THE MUNICIPALITY OF ASINGAN, PANGASINAN

Be it enacted by the Sangguniang Bayan of Asingan, Pangasinan, in session assembled that:

- **Section 1. Title**. This Ordinance shall be known as "An ordinance renaming the Government Center to Asingan Legislative Building of the Municipality of Asingan, Pangasinan".
- **Section 2. Purpose**. To remove the misconception of the constituents that the named Government center is the Health Center Building;
- **Section 3. Repealing Clause** All ordinance, rules and regulations, other issuances or parts thereof which are inconsistent with this Ordinance is hereby repealed.
- Section 4. Separability Clause If any part of the Ordinance is declared invalid, unconstitutional or unlawful, section or parts thereof which are not affected shall remain or continue to be in full force and effect.
- **Section 5. Effectivity.** This Ordinance shall take effect in accordance with the provision of republic Act No. 7160, also known as the Local Government Code of 1991, as amended.
