RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

ORDINANCE NO 4 SERIES 2023

AN ORDINANCE ABOLISHING TWO (2) VACANT POSITIONS, UNDER THE MUNICIPAL ACCOUNTANT OFFICE, ACCOUNTANT 1 (SALARY GRADE 12), PLANTILLA ITEM NUMBER 1081 – 003 AND FROM THE OFFICE OF THE MAYOR, ENVIRONMENT MANAGEMENT SPECIALIST I (SALARY GRADE 11), PLANTILLA ITEM NUMBER 1011-011

Be it enacted by the Sangguniang Bayan of Asingan, Pangasinan, in session assembled that:

Section 1. Title. This ordinance shall be known as "An ordinance abolishing two (2) vacant positions, under the Municipal Accountant Office, Accountant 1(Salary Grade 12), Plantilla Item Number 1081-003 and from the Office of the Mayor, Environment Management Specialist 1 (Salary Grade 11), Plantilla Item Number 1011 – 011.

Section 2. The positions of Accountant 1, (Salary Grade 12) and Environment Management Specialist 1 (Salary Grade 11) are hereby abolished.

Section 3. The budget allocation shall be used for the creation of other positions necessary to compliment the delivery of public service.

Section 4. Repealing Clause. If any provision or part of any of this Ordinance shall be declared unconstitutional or invalid, the same shall not affect the constitutionality or validity of the other provisions or part hereof.

Section 5. Effectivity. This Ordinance shall take effect upon approval and compliance with the mandatory posting and publication requirement, prescribed under R.A. 7160, otherwise known as the Local Government Code of 1991.
