EXPLANATORY NOTE

WHEREAS, Section 21 of the Local Government Code of 1991 states that: "Closure and Opening of Roads. – (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the sanggunian, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

WHEREAS, a new public market will be constructed and based on the proposed plan of Phase 1, Building B and some portions of pavilion A will be demolished;

WHEREAS, public market stall owners and tricycle drivers/operators parking areas will be relocated;

NOW THEREFORE, on motion of SB Member Melchor J. Cardinez, Sr., duly seconded by SB Members Marivic S. Robeniol, Mel F. Lopez, Joselito V. Viray and Julio P. Dayag, it was,

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

**ORDINANCE NO. 6
SERIES 2024**

AN ORDINANCE TEMPORARILY CLOSING THE HALF LANE IMMEDIATELY NEAR THE PUBLIC MARKET AT J. MILLAN STREET FROM THE PINE DRUG STORE UNTIL THE P. RAMOS STREET (ASINGAN-VILLASIS PROVINCIAL ROAD) FROM AUGUST 1, 2024 TO AUGUST 1, 2025

Section 1. Title – This ordinance shall be known as "An ordinance temporarily closing the half lane immediately near the public market at J. Millan Street from the Pine Drug Store until the P. Ramos Street (Asingan-Villasias Provincial Road) from August 1, 2024 to August 1, 2025;

Section 2. Coverage – To address the immediate traffic problems, prior and during the construction a new public market building;

Section 3. Objective:

- To avoid accident and traffic congestion;
- Easy traffic flow to all motorist traversing the area.

Section 4. Repealing Clause. All ordinances, resolutions, rules and regulations which are inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly.

Section 5. Effectivity. This Ordinance shall take effect after proper posting and publication in a newspaper of general circulation.
