EXPLANATORY NOTE

WHEREAS, the United Federation of Tricycle Operators and Drivers Associations of Asingan, Pangasinan submitted their letter to the Sangguniang Bayan requesting for tricycle fare rate increase due to the uncontrollable increase of gasoline and other oil products;

WHEREAS, one of the barometers of our economy depends on the oil industry, increase in all products will mean increase of prime commodities;

WHEREAS, implementing rules and regulations of the Local Government Code of 1991, Article 100, paragraph 3, subparagraph (vi) provides;

(vi) subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycle and grant franchises for the operation thereof within the territorial jurisdiction of the Municipality.

NOW THEREFORE, on motion of Councilor Carlos F. Lopez, Jr., duly seconded by Councilors Porferio R. Tendaro, Jesus G. Cardinez and Roseller A. Viray, it was

RESOLVED, as it is hereby resolved, to approve the following Ordinance, to wit:

AN ORDINANCE IMPOSING FARE RATE INCREASE FOR MOTORIZED TRICYCLES PLYING THEIR ROUTE WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF ASINGAN, PANGASINAN

Be it enacted by by the Sangguniang Bayan of Asingan, in session assembled, that:

Section 1. Title. – An Ordinance imposing fare rate increase for tricycle plying their route within the territorial jurisdiction of the Municipality of Asingan.

Section 2. The Committee on Public Works, Utilities and Facilities thru public hearing held on January 6, 2011, with the United Federation and Tricycle Operators and Drivers Association, Barangay Captains, Non-government Organization (NGOs) and concerned citizens, and recommended that the increase to be imposed shall be decided by the Sangguniang Bayan Members;

Section 3. The new fare rate shall be as follows:

Php10.00 for the first kilometer; and
Additional Php1.00 for every succeeding kilometer.

Section 4. Senior Citizens, students and persons with disability shall be given a discount of twenty percent (20%) of the fare rate from Monday to Sunday.

Section 5. The fare rates shall be posted on a conspicuous place inside the motorized tricycle and within the premises of the terminals of various Tricycle Drivers and Operators Association in the Municipality.

Section 6. Any tricycle driver found violating Sections 3, 4 and 5 of this ordinance shall be subject to the following penalties:

- a. FOR THE FIRST OFFENSE, an imprisonment of one (1) month or a fine of Php1,000.00 or both at the discretion of the court.
- b. FOR THE SECOND OFFENSE, an imprisonment of two (2) months or a fine of Php1,500.00 or both at the discretion of the court.
- c. FOR THE THIRD OFFENSE, an imprisonment of three (3) months or a fine of Php2,000.00 or both at the discretion of the court.

Section 7. Any existing ordinance, which is inconsistent with the provision of this Ordinance, is hereby repealed.

Section 8. This ordinance shall take effect after proper posting and/or publication as required by law.
