RESOLUTION REQUESTING DIRECTOR DIONISIO G. ALVINDIA, PhD, DIRECTOR IV, PHILIPPINE CENTER FOR POSTHARVEST DEVELOPMENT AND MECHANIZATION, SCIENCE CITY OF MUNOZ, NUEVA ECIJA, TO PROVIDE FOUR (4) WHEEL TRACTOR AND SIX HUNDRED (600) SQUARE METER RICE PROCESSING CENTER FOR THE MUNICIPALITY OF ASINGAN, PANGASINAN

SB Member Julio P. Dayag presented for consideration and approval the following resolution, to wit:

WHEREAS, the Municipality of Asingan is a second (2nd) Class Agricultural town located in the eastern part of Pangasinan;

WHEREAS, there are three thousand five hundred (3,500) farmers more or less who cultivates a total land area of four thousand two hundred twenty-eighty (4,228) hectares devoted to palay which is planted twice a year;

WHEREAS, Year-round irrigation is provided by the nearby San Roque Dam located in San Manuel, Pangasinan;

WHEREAS, in order to improve the efficiency of farming and thereby increase their yield of palay, the following should be provided:

1. Four (4) Wheel Tractor

2. Six Hundred (600) Square Meter Rice Processing Center
