RESOLUTION RECOGNIZING THE ASINGAN PEOPLE'S COUNCIL REPRESENTED BY THE REPRESENTATIVE OF THE CIVIL SOCIETY ORGANIZATIONS (CSO's) IN THE MUNICIPALITY OF ASINGAN, PANGASINAN

Councilor Melchor J. Cardinez, Sr. presented for consideration and approval the following resolution, to wit:

WHEREAS, WHEREAS, pursuant to R.A. 7160 otherwise known as the 1991 Local Government Code, Sec. 34. Role of People's and Non-government Organizations; Local Government Units shall promote the establishment and operation of people's and non-governmental organizations to become active partners in the pursuit of local autonomy;

WHEREAS, the Department of the Interior and Local Government Issued Memorandum Circular No. 2021-054, on the "Amendment to the DILG Memorandum Circular No. 2021-012, on the Establishment of Civil Society Organization Desk and Institutionalization of people's Council in the Local Government Unit;

WHEREAS, the Asingan People's Council submitted Council Resolution No. 1, S-2022, facilitating the formal creation of the Asingan People's Council (APC);

WHEREAS, the People's Council Rights and Privileges are the following:

1. Autonomy to elect from among its members, its set of officers and determine its internal rules;
2. Sole prerogative to identify its principal and alternate representatives in various local government councils, committees, task forces, or special bodies where it sits as members. Such representatives shall not exceed twenty five (25) percent of the membership of the board, council, committee, task force, or special body, pursuant to Section 107 of the RA 7610;
3. If allowed by Sanggunian, propose legislation and participate and vote at the committee level of the local Sanggunian;
4. Funding for capacity development trainings and applicable allowances/honorarium/per diem; and
5. Allocation of funding support for the provision of necessary office space, facilities, supplies, and paraphernalia of the People's Council.


