RESOLUTION AUTHORIZING ENGR. CARLOS F. LOPEZ, JR., MUNICIPAL MAYOR, ASINGAN, PANGASINAN, TO ENTER INTO AND SIGN THE MEMORANDUM OF UNDERSTANDING (MOU) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REPRESENTED BY MS. MARIE ANGELA S. GOPALAN, REGIONAL DIRECTOR WITH REGARDS TO THE SUPPLEMENTARY **FEEDING PROGRAM**

SB Member Marivic S. Robeniol presented for consideration and approval the following resolution, to wit:

WHEREAS, the Supplementary Feeding Program (SFP) is the provision of food in addition to the regular meals to target children ages 3-4 years old enrolled in the Child Development Center (CDCCs) and Supervised Neighborhood Play (SNPs) as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government;

WHEREAS, the Department of Education (DepEd) and the Department of Social Welfare and Development (DSWD), in consultation with other National Government Agencies (NGAs), Local Government Units (LGUs), Non-Government Organizations (NGOs), and development partners, are mandated by Republic Act No.11037 also known as "Masustansyang Pagkain Para sa Batang Pilipino", to promulgate their respective rules and regulations for the efficient and effective implementation of the National Feeding program for Public Day Care Centers (PDCCs), public kindergarten and elementary schools, pursuant to Section 4 of the said law to address undernutrition among Filipino children;

WHEREAS, under Section 4 (a) of RA No. 11037, the DSWD, in coordination with the LGUs, has been tasked to implement a SFP for undernourished children with ages three (3) to four (4) years which shall include the provision of at least one 91) fortified meal for a period of not less than one hundred twenty (120) days in a year;

WHEREAS, the efficient and effective implementation of a national feeding program shall sustain the gains of good nutrition achieved through the delivery of ECCD services consistent with RA No. 10410, otherwise known as the "Early Years Act of 2013" and quality basic education services under RA No. 10533, otherwise known as the "Enhanced basic Education Act of 2013";

WHEREAS, the General Appropriation Act of 2023 stated that the target outcome indicator of SFP is 80% of malnourished children in CDCs and SNPs with improved nutritional status;

WHEREAS, given the limitation in the purchasing power of most families due to extended effect of the COVID-19 pandemic and inflation of food commodities, SFP implementation shall assist in addressing the issue of hunger and food security among Filipino children and prevent regression of the current nutritional status of the beneficiaries.

NOW THEREFORE, on motion of SB member Marivic S. Robeniol, duly seconded by SB Member Melchor J. Cardinez, Sr., it was,

RESOLVED, as it is hereby resolved, to authorize Engr. Carlos F. Lopez, Jr., Municipal Mayor, Asingan, Pangasinan, to enter into and sign the Memorandum of Understanding (MOU) with the Department of Social Welfare and Development (DSWD) represented by Ms. Marie Angela S. Gopalan, Regional Director, with regards to the Supplementary Feeding Program.

RESOLVED FURTHER, to send copies of this resolution to Ms. Marie Angela S. Gopalan, Regional Director, Department of Social Welfare Development (DSWD), Field Office 1, Quezon Avenue, San Fernando City, La Union and Engr. Carlos F. Lopez, Jr., Municipal Mayor, Asingan, Pangasinan, for their information and guidance.
