WHEREAS, the Technical Education and Skills Development Authority (TESDA) formulates manpower and skills plans, sets appropriate skills standards and tests, coordinates and monitors manpower policies and programs, and provide policy directions and guidelines for resource allocation for the TVET institutions in both the private and public sectors;


