**RESOLUTION ADOPTING PROVINCIAL RESOLUTION NUMBER 748-2022, URGING ALL BARANGAY CAPTAINS AND SANGGUNIANG KABATAAN CHAIRMEN TO DISCOURAGE THE HOLDING OF PUBLIC GATHERINGS IN THEIR AREAS OF JURISDICTION**

Councilor Leticia R. Dollente presented for consideration and approval the following resolution, to wit:

WHEREAS, the barangays serve as the primary planning and implementing unit of government policies, plans, programs, projects, and activities in the community;

WHEREAS, during the height of the pandemic, the barangays have ably helped the provincial government implement programs and projects aimed to minimize, if not prevent, the spread of COVID-19;

WHEREAS, the World Health Organization has already pronounced that it has never been in a better position to end the pandemic although "we are not there yet, but the need is in sight";

WHEREAS, the barangays will play important roles to help end the pandemic by not being in a complacent but should continue to take necessary steps in combating COVID-19;


RESOLVED FURTHER, to send copies of this resolution to all Punong Barangays of Asingan, Pangasinan and all other concern, for their information and guidance.
