2. Peace and order should be maintained;
3. Properties that will be destroyed in the plaza on the duration of their barangay fiesta should be restored and that restoration be the responsibility of the amusement contractor;
4. Beerhouses, videoke bars, restaurants and any other establishments employing bar girls shall be strictly prohibited;
5. Minors are not allowed to drink any kind of intoxicating liquors and to gamble;
6. Any person found to have drink excessively with a manifestation of unruliness shall be confined to the Asingan Police Station for a period of six (6) hours.

NOW THEREFORE, on motion of Councilor Mark E. Abella, duly seconded by Councilors Virgilio I. Amistad, Alain C. Sindayen and Dolores A. Tabin, it was
