## **EXECUTIVE ORDER NO. 0003-C, S-2023**

## DESIGNATING THE SOCIAL WORKER ON STIMULATION AND THERAPEUTIC ACTIVITY CENTER (STAC) OF THE MUNICIPALITY OF ASINGAN, PANGASINAN, AND FOR OTHER PURPOSES

WHEREAS, it is the government's concern and responsibility to assist persons with disabilities as provided by Republic Act No. 7277 or the "Magna Carta for Persons with Disabilities" and the "United Nations Convention on the Rights of Persons with Disabilities." The state shall therefore provide for the rehabilitation and training of children and young adults with disabilities to ensure their right to live freely and independently and to achieve a more meaningful, productive, and satisfying life;

WHEREAS, the Municipality of Asingan has adopted the Breaking Barriers for Children and Young Adults with Disabilities (BBCY) initiative and established a Stimulation and Therapeutic Activity Centers (STAC) for children with disabilities (CWD) designed to improve their mobility and skills, and empower them to become productive members of society;

SECTION 1. NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me and by expressed authority provided for by law to the Local Chief Executive, do hereby designate BLESSEL ANNIELY F. NABOR (Social Welfare Officer I) as the SOCIAL WORKER on Stimulation and Therapeutic Activity Center of the Municipality of Asingan, Pangasinan, with the following duties and responsibilities:

## SECTION 2. DUTIES AND RESPONSIBILITIES.

- a) Assist in the identification and extending assistance to children and young adults with disabilities in the communities;
- b) Craft detailed plans in the implementation of various interventions among families of CWDs and PPAs in the municipality;
- c) Initiate the conduct of socio-economic impact assessments;
- d) Facilitate planning and referrals to government agencies and civil society organizations for livelihood assistance for economically-marginalized families;
- e) Identify potential Parent Association Leaders (PALs) and organize them in their respective target areas;
- Plan and monitor advocacy and community awareness activities that highlight disability issues and facilitate PAL meetings and dialogues and CWD activities; and
- g) Plan, implement, and monitor parent-child counseling, home visitation, referrals and linkages concerned agencies and other relevant social rehabilitation activities;
- h) Prepare and submit social case studies, social progress reports, and quarterly/annual reports; and
- Establish close coordination and linkage with health workers from the Health Office;
- Perform such other functions as may be directed to by the MSWD Officer or the Municipal Mayor in accordance with existing laws and ordinances.

SECTION 3. EFFECTIVITY. This Order shall take effect immediately.
