EXECUTIVE ORDER NO. 0003, S-2023

DESIGNATING THE FOCAL PERSON ON EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) OF THE MUNICIPALITY OF ASINGAN, PANGASINAN, AND FOR OTHER PURPOSES

WHEREAS, it is the policy of the State to promote the rights of children to survival, development, and special protection with full recognition of the nature of the childhood as well as the need to provide developmentally-appropriate experiences to address their needs; and to support parents in their roles as primary caregivers and as their children's first teachers;

WHEREAS, in consonance with the said State policy, the passage of Republic Act No. 10410, otherwise known as the Early Years Act (EYA) of 2013, institutionalizes the National System for Early Childhood Care and Development (ECCD) that is comprehensive, integrative and sustainable, that involves multisectoral and interagency collaboration at the national and local levels among government; among service providers, families and communities, and among the public and private sectors, nongovernment organizations; professional associations and academic institutions;

WHEREAS, the DILG issued Memorandum Circular No. 2002-121 or the "Revised Guidelines on the Organization and Strengthening of the Local Council for the Protection of Children (LCPC), incorporating thereat Early Childhood Care and Development (ECCD) Coordinating Committees at the Provincial, City, Municipal and Barangay Levels";

SECTION 1. NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me and by expressed authority provided for by law to the Local Chief Executive, do hereby designate MARICEL A. BADUA (MSWD Office Clerk) as the FOCAL PERSON on the Early Childhood Care and Development (ECCD) of the Municipality of Asingan, Pangasinan, with the following duties and responsibilities:

SECTION 2. DUTIES AND RESPONSIBILITIES.

- a) Assist in the formulation of long-term and medium-term, and annual plans and policies of the Municipality on Early Childhood Care and Development (ECCD) programs, and recommend the same to the Municipal Mayor for approval;
- b) Coordinate and monitor the implementation of ECCD programs such as early childhood education, supplementary feeding, and training programs;
- c) Prepare project proposals, reports, and documentations;
- d) Facilitate the meeting of, engage Childhood Development Workers (CDWs), and monitor and review report submission of CDWs; and
- e) Perform such other functions as may be directed to by the MSWD Officer or the Municipal Mayor in accordance with existing laws and ordinances.

SECTION 3. EFFECTIVITY. This Order shall take effect immediately.
