### EXECUTIVE ORDER NO. 0019-A, S-2022

#### CREATING THE MATERNAL, NEONATAL, AND CHILD HEALTH AND NUTRITION (MNCHN) PROGRAM OF THE MUNICIPALITY OF ASINGAN, PANGASINAN, CONSTITUTING THE MNCHN TASK FORCE, AND PROVIDING FOR ITS DUTIES AND FUNCTIONS, AND FOR OTHER PURPOSES

**WHEREAS**, the Department of Health (DOH) formulated and implemented and integrated Maternal Newborn Child Health and Nutrition Strategy pursuant to Administrative Order No. 003, s. 2005; the National Objectives for Health (NOH) 2005-2010; the Philippine commitments to the Millennium Development Goals (MDG) for 2015; the lessons obtained from various maternal and child health projects; National Health Sector Meeting Resolution No. 2008-01-02; DOH Executive Committee (Execom) resolution dated February 4, 2008 with a subsequent reiteration in DOH Execom Resolution, as supplemented by DOH Execom Resolutions dated July 21 and 30, 2008; as well as in compliance with the 1992 Philippine Midwifery Act or Republic Act (RA) 7392; the Early Childhood Development Act (RA 8980) of 2000; the Newborn Screening Law (RA 9288) of 2004; Executive Order 286 on the Bright Child Program, 2004; Executive Order 51 on the Milk Code, 1986; the Rooming-In and Breastfeeding Act (RA 7600) of 1992; and, other related laws;

**WHEREAS**, DOH AO No. 2008-0029 "Implementing Health Reforms for Rapid Reduction of Maternal and Neonatal Mortality" dated September 9, 2008 was issued to guide the development, implementation and evaluation of various programs aimed at women, mothers and children, with the ultimate goal of rapidly reducing maternal and neonatal mortality in the country. It shall also serve as guide in the engagement, assistance and empowerment of local government units (LGUs) and other partners in rapidly achieving the maternal and neonatal mortality reduction goal;

**WHEREAS**, there is a need to strengthen the Maternal, Neonatal, and Child Health and Nutrition Program in the municipality to achieve the goal of rapidly reducing maternal and neonatal mortality through effective population-wide provision and use of integrated MNCHN services for women, mothers and children;

**NOW, THEREFORE**, I, Engr. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me by law, do hereby order and decree the following:

**SECTION 1. COVERAGE.** This Order shall apply to all public and private health care providers and development partners implementing the Maternal, Neonatal, and Child Health and Nutrition Strategy and covered by the DOH AO No. 2008-0029.

**SECTION 3. DUTIES AND FUNCTIONS.** The Task Force shall be the overall coordinating and implementing body for the implementation of the MNCHN Strategy and Plan in the municipality. In addition, the Task Force shall perform and exercise the following duties and functions

- Formulate a comprehensive MNCHN Plan and oversee its implementation;
- Undertake program monitoring and evaluation and provide a program feedback mechanism;
- In close coordination with barangay governments and other agencies concerned, conduct and update date of Women of Reproductive Age (WRA) and FP users;
- Provide support in strengthening capacities for FP/MNCHN service provision through the conduct of training courses and other capacity-building activities;
- Provide support in the conduct of activities related to FP/MNCHN education and counselling of clients about FP and safe motherhood; and
- Establish and maintain linkages with local, national or even international population serving organizations or institutions.

**SECTION 4. REPEALING CLAUSE.** All orders, rules, regulations, and other related issuances inconsistent with or contrary to this Order are hereby repealed, amended, or modified accordingly. All other provisions of existing issuances which are not affected by this Order shall remain valid and in effect

**SECTION 5. SEPARABILITY CLAUSE.** In the event any provision in this Order shall be declared invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired thereby.

**SECTION 6. EFFECTIVITY.** This Order shall take effect immediately.

### EXECUTIVE ORDER NO. 0020, S-2022

## CONSTITUTING THE REVIEW AND COMPLIANCE COMMITTEE (RCC) FOR THE STATEMENT OF ASSETS, LIABILITIES, AND NET WORTH (SALN) OF THE MUNICIPALITY OF ASINGAN, PANGASINAN, AND FOR OTHER PURPOSE

**WHEREAS**, Section 17, Article XI of the 1987 Philippine Constitution requires public officers and employees to submit upon assumption of office and during such period as may be required by law, a declaration under oath of their assets, liabilities, and net worth (SALN);

**WHEREAS**, Section 8 of the Republic Act No. 6713 (Code of Conduct and Ethical Standards for Public Officials and Employees) requires the declarant *"to accomplish and submit declarations under oath of, and the public has the right to know, their assets, liabilities, net worth, and financial and business interests including those of their spouses and of unmarried children eighteen (18) years of age living in their households;"*

**WHEREAS**, Section 12 of the same law provides that the Civil Service Commission shall have the primary responsibility for its administration and enforcement, and the authority to promulgate rules and regulations necessary to carry out its provisions;

**WHEREAS**, CSC Resolution No. 1300455 dated March 4, 2013 recognized the need to amend and clarify the persons authorized to review and evaluate the submitted SALNs and resolved to adopt guidelines in the review and compliance procedure in the filing and submission of the SALN;

**NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR.**, Municipal Mayor of Asingan, Pangasinan, premises considered, by expressed authority provided for by law to the Local Chief Executive, hereby order the following:

**SECTION 1. COMPOSITION.** The Review and Compliance Committee (RCC) for SALN of the Municipality of Asingan, Pangasinan, shall be composed of the following:

**SECTION 2. DUTIES AND FUNCTIONS.** The Review and Compliance Committee (RCC) for SALN shall have the following roles and responsibilities:

1. Ensure the timely and complete submission of SALN of employees; and
2. Prepare and submit a list of employees, in alphabetical order, to the head of agency, copy furnished the Civil Service Commission, on or before May 15 of every year.

**SECTION 3. EFFECTIVITY.** This Order shall take effect immediately.
