### EXECUTIVE ORDER NO. 0035-B, S-2022

#### MANDATING THE 24/7 OPERATION OF THE MDRRMO COMMAND CENTER OF THE MUNICIPALITY OF ASINGAN DURING DISASTERS, HAZARDS, VULNERABILITIES, AND RISKS

**WHEREAS**, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 mandates that it shall be the policy of the state to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disaster, strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disaster including climate change impacts;

**WHEREAS**, Section 12 of RA 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, mandates the establishment of an LDRRMO in every province, city, and municipality, and a BDRRMC in every barangay which shall be responsible for setting the direction, development, implementation, and coordination of disaster risk management programs within their territorial jurisdiction;

**WHEREAS**, pursuant to this need, Section 13 of the said law mandates the government agencies, CSOs, private sector and local government units to mobilize individuals or organized volunteers to augment their respective personnel complement and logistical requirements in the delivery of disaster risk reduction programs and activities; and

**WHEREAS**, the geographical location of Asingan makes it vulnerable to flood, tropical cyclone extreme rainfall, fire, earthquake and other hazards which bring havoc to life and property, causing disruption to the normal lives of its inhabitants;

**WHEREAS**, it is highly imperative to address disasters, examine the vulnerable elements in the community, adopt measures to reduce the risks and put in place a holistic disaster risk reduction and management scheme in the Municipality to deal with the natural and man-made adversities before, during and after and more importantly even during normal situation;

**WHEREAS**, there is a necessity to ensure the functionality of the MDRRMO Command Center, operability of its equipment and facilities, and 24/7 operation of personnel, allied units/offices, and volunteers in times of disasters, hazards, vulnerabilities, and risks;

**NOW THEREFORE, I, CARLOS F. LOPEZ, JR.**, Mayor of the Municipality of Asingan and concurrent Chairman of the Municipal Disaster Risk Reduction and Management Council, by virtue of the powers vested in me by law and the Constitution, do hereby order 24/7 Operation of the MDRRMO Command Center of the Municipality of Asingan, Pangasinan in times of disasters, hazards, vulnerabilities and risks.

This Executive Order shall take effect immediately.
