EXECUTIVE ORDER NO. 0035-C, S-2022

DESIGNATING STAFF COMPLEMENT OF THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (MDRRMO) OF THE MUNICIPALITY OF ASINGAN, PANGASINAN, AND FOR OTHER PURPOSE

WHEREAS, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 mandates that it shall be the policy of the state to uphold the people's constitutional rights to life and property by addressing the root causes of vulnerabilities to disaster, strengthening the country's institutional capacity for disaster risk reduction and management, and building the resilience of local communities to disaster including climate change impacts;

WHEREAS, Section 12 of RA 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010, mandates the establishment of an LDRRMO in every province, city, and municipality, and a BDRRMC in every barangay which shall be responsible for setting the direction, development, implementation, and coordination of disaster risk management programs within their territorial jurisdiction;

WHEREAS, Section 12(b) provides that LDRRMO shall be under the office of the governor, city or municipal mayor, and the punong barangay in case of the BDRRMC. The LDRRMOs shall be initially organized and composed of a DRRMO to be assisted by three (3) staff responsible for: (1) administration and training; (2) research and planning; and (3) operations and warning. The LDRRMOs and the BDRRMCs shall organize, train, and directly supervise the local emergency response teams and ACDVs; and

NOW THEREFORE, I, CARLOS F. LOPEZ, JR., Mayor of the Municipality of Asingan, Pangasinan, by virtue of the powers vested in me by law and the Constitution, do hereby and decree the following:

SECTION 1. DESIGNATION of the following LGU Asingan personnel as staff complement of the Municipal Disaster Risk Reduction and Management Officer (MDRRMO):

NIKKI PAUL P. VILLOTA – Admin Aide I (Ambulance)

SECTION 2. DUTIES AND FUNCTIONS.

1. Assist the LDRRMO in the preparation of the annual LDRRMC Plan and Budget for submission to the Sangguniang Bayan for appropriate action;
2. Gather and disseminate information to raise public awareness about hazards, early warning signs and counter measures;
3. Prepare and submit reports on the utilization of the LDRRMF and other resources to the COA, DBM, OCD, and the DILG Regional Office;
4. Accomplish other related tasks upon instruction of the MDRRMO.

This Executive Order shall take effect immediately.
