EXECUTIVE ORDER NO. 004, S. 2022

CONSTITUTING THE COMMUNITY-BASED MONITORING SYSTEM TECHNICAL WORKING GROUP (CBMS-TWG) OF THE MUNICIPALITY OF ASINGAN, PANGASINAN, AND FOR OTHER PURPOSE

WHEREAS, it is the policy of the State to free the people from poverty through policies that provide adequate social services, deliver a rising standard of living, promote full employment, and make available an improved quality of life for all;

WHEREAS, Republic Act No. 11315 or the Community-Based Monitoring System Act was passed to adopt a community-based monitoring system which generates updated and disaggregated data necessary in targeting beneficiaries conducting more comprehensive poverty analysis and needs prioritization, designing appropriate policies and interventions, and monitoring impact over time;

WHEREAS, the Implementing Rules and Regulations (IRR, for brevity) of R.A. 11315 states the priorities of the National Government in relation to poverty reduction:

- a) Adopt a community-based monitoring system which generates the updated and disaggregated data necessary in targeting beneficiaries;
- b) Conduct more comprehensive poverty analysis and needs prioritization;
- c) Design appropriate policies and interventions;
- d) Provide mechanism for impact monitoring over time;
- e) Provide information that will enable a system of public spending that warrants government allocation on areas and populace that are most wanting;
- f) Establish a data collection, data sharing, and information management system which shall respect the fundamental human right to privacy, ensure data quality, and uphold data protection principles of legitimate purpose, transparency, and proportionality;
- g) Establish CBMS database at the national and city/municipal level; and
- h) Generate relevant statistics at higher levels that will complement and supplement the local level data.

WHEREAS, there is a necessity to organize the Community-Based Monitoring System – Technical Working Group (CBMS-TWG) to carry out the provisions of R.A. 11315;

NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., Local Chief Executive of the Municipality of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me by law, do hereby order and decree:

SECTION 1. COMPOSITION. The CBMS-TWG shall be composed of the following:

SECTION 2. FUNCTIONS OF THE CBMS-TWG. There is a need for collaboration with concerned agencies to accomplish the primary purpose of the CBMS which is to establish a monitoring tool for poverty diagnosis and SDG monitoring for a more data-based and evidence-based planning and programming; and for monitoring the effects of policies and programs on the socio-economic conditions in their respective jurisdictions:

- Assist the agency in the conduct of synchronized data collection on CBMS every three (3) years with the necessary financial and technical assistance from the appropriate national government agencies pursuant to Section 5 of the CBMS Act;
- Oversee the progress of the implementation of the CBMS and shall strictly follow the timelines set forth to ensure the reliability and validity of the data;
- c. Conduct sectoral/intersectoral analysis and validation of reports;
- d. Conduct surveys, consultations, meetings and workshops;
- e. Integrate and finalize studies, research findings and survey outputs;
- f. Draft and consolidate the contents of the CBMS document;
- g. Participate in CBMS-related advocacy, training, and capacity-building activities;
- h. Ensure that CBMS-generated data is utilized in local governance processes such as but not limited to local planning, investment programming, budgeting, program identification and implementation, as well as disaster risk reduction and management measures:
- i. Implement measures on sharing of CBMS data in accordance with the data-sharing guidelines issued by the CBMS Council; and
- i. Perform other necessary functions as may be assigned.

SECTION 3. FUNCTIONS OF THE CBMS Secretariat. The Municipal Planning and Development Office shall serve as the CBMS Secretariat to undertake the following roles:

- a. Oversee the progress of the implementation of the CBMS and shall strictly follow the timelines set forth to ensure the reliability and validity of the data;
- b. Conduct sectoral/intersectoral analysis and validation of reports;
- c. Conduct surveys, consultations, meetings and workshops;
- d. Integrate and finalize studies, research findings and survey outputs;
- e. Draft and consolidate the contents of the CBMS document; and
- f. Perform other necessary functions as may be assigned.

SECTION 4. EFFECTIVITY

This order shall take effect immediately.
