EXECUTIVE ORDER NO. 006, SERIES OF 2025

REORGANIZING THE MUNICIPAL AWARDS COMMITTEE (MAC) FOR THE LUPONG TAGAPAMAYAPA INCENTIVES AWARDS (LTIA) OF THE OF THE MUNICIPALITY OF ASINGAN, PANGASINAN, AND FOR OTHER PURPOSE

WHEREAS, Section 399 of RA 7160 or the Local Government Code of 1991 provides for the creation in each Barangay a Lupong Tagapamayapa, composed of the Punong Barangay as Chairperson and 10 to 20 members. The Lupon shall be constituted every three (3) years in the manner provided in the DILG Memorandum Circular No. 2023-022 "Lupong Tagapamayapa Incentives Awards Enhanced Criteria and Guidelines", as amended by Executive Order No. 68, series of 2024;

WHEREAS, Section 406 (b) of RA No. 7160 provides that the DILG shall provide for a system of granting economic or other incentives to the Lupon or pangkat members who adequately demonstrate the ability to judiciously and expeditiously resolve cases referred to them;

WHEREAS, in 1982, the Lupong Tagapamayapa Incentives Awards (LTIA) was conceptualized and implemented, and eventually elevated into a Presidential Award pursuant to Executive Order No. 394, s. 1997;

WHEREAS, the LTIA recognizes the outstanding lupong tagapamayapa that adequately demonstrates the ability to judiciously and expeditiously resolve cases referred to them and demonstrate exemplary performance and commendable contribution in the promotion and implementation of Katarungang Pambarangay (KP), which aims to:

- a) Strengthen the Katarungang Pambarangay (KP) as an Indigenous conflict Resolution structure at the grassroots level;
- b) Institutionalized a style of granting economic benefits and other incentives to Lurons which demonstrate exemplary performance; and
- c) Generate greater awareness among, and support from, the various sectors of Philippine society on the KP as a potent vehicle toward social order and human development;

SECTION 1. NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., Mayor of the Municipality of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me by law, do hereby order and decree the Reorganization of the Municipal Awards Committee (MAC) for the Lupong Tagapamayapa Incentives Awards (LTIA) of the Municipality of Asingan, pursuant to DILG MC No. 2024-174.

SECTION 2. COMPOSITION. Municipal Awards Committee for the LTIA shall be composed of:

SECTION 3. FUNCTIONS. The Municipal Awards Committee shall have the following duties and responsibilities:

- Initiate and coordinate the necessary activities toward the successful implementation of the LTIA in their respective level;
- Disseminate information on the Awards to generate awareness and support from the public and private sectors in their respective region;
- Select and submit to the PAC the best performing Lupons within the municipality;
- May secure funding and counterpart prizes from the partner agencies and the private sector; and
- May plan and implement appropriate awarding ceremonies.

SECTION 4. SECRETARIAT. In order to assist it in the discharge of its functions, the Secretariat of the MAC shall be the Municipal Local Government Operations Office. The Secretariat shall be responsible in the documentation of the proceedings, preparation of reports, and other secretarial works required.

SECTION 5. REPEALING CLAUSE. All orders, rules, regulations, and other related issuances inconsistent with or contrary to this Order are hereby repealed, amended, or modified accordingly. All other provisions of existing issuances which are not affected by this Order shall remain valid and in effect.

SECTION 6. SEPARABILITY CLAUSE. In the event any provision in this Order shall be declared invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired thereby.

SECTION 7. EFFECTIVITY. This Order shall take effect immediately.
