EXECUTIVE ORDER NO. 012, SERIES OF 2025

AN ORDER CREATING THE SEAL OF GOOD LOCAL GOVERNANCE INCENTIVE FUND (SGLGIF) PROJECT IMPLEMENTATION TEAM (PIT) AND ITS TECHNICAL WORKING GROUP (TWG) OF THE LOCAL GOVERNMENT UNIT OF ASINGAN

WHEREAS, the Seal of Good Local Governance Incentive Fund (SGLG Incentive Fund), a performance-based challenge fund, was institutionalized through Republic Act No. 11292, also known as the *Seal of Good Local Governance Act of 2019*, and is a Local Government Development Program managed by the SGLG Council composed of various National Government Agencies (NGAs);

WHEREAS, the SGLG Incentive Fund is a progressive incentive system granted to eligible LGUs in the form of a counterpart fund to finance high-impact local development projects, and to further encourage effective, transparent, and accountable public service delivery;

WHEREAS, the Seal of Good Local Governance promotes honest and effective governance by enforcing policies such as the Full Disclosure Policy, and being an SGLG awardee is a requirement for the availment of the SGLG Incentive Fund;

WHEREAS, the Municipality of Asingan received a **Notice of Eligibility** dated April 7, 2025 from **Regional Director Jonathan Paul M. Leusen, Jr., CESO III, DILG Region 1**, confirming its qualification to avail of the CY 2024 **SGLG Incentive Fund** amounting to **One Million Three Hundred Thousand Pesos (P1,153,000.00)**;

WHEREAS, in compliance with the requirements for the release and implementation of the SGLG Incentive Fund, there is a need to formally create a **Project Implementation Team (PIT)** to ensure efficient planning, implementation, monitoring, and reporting of the funded project.

NOW THEREFORE, I, Engr, CARLOS F. LOPEZ, JR., of Local Government Unit of Asingan, Pangasinan, by virtue of the power vested in me by law and the Constitution, do hereby create the SGLGIF Project Implementation Team (SGLGIF-PIT) in the Local Government Unit of Asingan

Section 1. CREATION. There shall be created the **SGLG Incentive Fund Project Implementation Team** and its **Technical Working Group (TWG)** for the Local Government Unit of Asingan.
