EXECUTIVE ORDER NO. 15, SERIES OF 2025

CREATING THE MUNICIPAL PLANNING TEAM OF THE MUNICIPALITY OF ASINGAN, PANGASINAN FOR THE UPDATING OF THE COMPREHENSIVE LAND USE PLAN FOR 2027-2037

WHEREAS, the review, revision, and updating of the Comprehensive Land Use Plan for the Municipality of Asingan is long overdue, as the current plan formulated in 2018 and intended to cover the period until 2027 is already nearing its completion, and the process of updating has commenced but remains ongoing due to the substantial volume of documents and technical requirements involved;

WHEREAS, two (2) landmark national laws, the Climate Change Act of 2009 (RA 9729) and the Disaster Risk Reduction and Management Act of 2010 (RA 10121), require the mainstreaming of climate change adaptation and disaster risk reduction in all national and local development plans including the Comprehensive Land Use Plan;

WHEREAS, there is also a need to integrate special areas and thematic concerns such as heritage, urban design and green growth in the land use planning process to ensure the conservation and sustainable management of these elements.

WHEREAS, it has become imperative to review, revise and update the Comprehensive Land Use Plan which is forward looking, adaptive and resilient to our constantly changing environment.

NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., of the Local Government Unit of Asingan, Pangasinan, by virtue of the powers vested in me as the Local Chief Executive, do hereby order the review, revision, and updating of the Municipal Planning Team, tasked with formulating a new Comprehensive Land Use Plan for the municipality, in collaboration with and with the technical assistance of the Housing and Land Use Regulatory Board.
