EXECUTIVE ORDER NO. 016-B, S-2023

REORGANIZING THE TECHNICAL SUPPORT TEAM FOR COMPONENT BADACs OF THE MUNICIPALITY OF ASINGAN, PANGASINAN

WHEREAS, it is mandated by RA 9165, RA 7160, relevant Dangerous Drug Board (DDB) Regulations, and DILG Memorandum Circulars respectively, that the Local Anti-Drug Abuse Councils, even in Barangays, be activated;

WHEREAS, barangay officials have the principal responsibility to support overall government efforts in addressing peace and order, particularly to curb illegal drugs and other substances, through the Barangay Anti-Drug Abuse Council (BADAC), which has a critical role in the coordination and proper monitoring of drug-related incidents;

BE THAT AS IT MAY, Municipal Anti-Drug Abuse Council of Asingan, Pangasinan, realized to strengthen the provision of technical support to all twenty-one (21) components BADACs through the creation of LGU Technical Support Team for component BADACs;

NOW THEREFORE, I, ENGR. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, by virtue of the powers vested in me by law, do hereby order the organization of the Technical Support Team for Component BADACs, to wit:

SECTION 1. COMPOSITION:

SECTION 2. DUTIES AND RESPONSIBILITIES. The Team shall perform the following duties and responsibilities:

1. The PNP will provide technical assistance in the overall operations of the BADAC;
2. Psycho-social support and other drug awareness programs may be provided by the MHO and MSWDO;
3. Technical assistance on the enactment of Barangay ordinances, laws and other issuances will be provided by MLGOO and LNB President; and
4. The MPDC and Municipal Budget Office will be in-charged in the capability building during planning and budgeting process to certainly include the Anti-Illegal PPAs in the Annual Barangay Budget.

This Order shall take effect immediately.
