### EXECUTIVE ORDER NO. 026, S-2023

#### DESIGNATING THE LGU FOCAL PERSON ON THE REMOVAL OF UNLAWFUL ELECTION PROPAGANDA MATERIALS IN LINE WITH THE 2023 BARANGAY AND SANGGUNIANG KABATAAN ELECTIONS, AND FOR OTHER PURPOSE

**WHEREAS**, the Commission on Election (COMELEC) promulgated Resolution No. 10924 on June 7, 2023, which provides for the "General Guidelines and Other Related Rules and Regulations for the October 30, 2023 Barangay and Sangguniang Kabataan Elections (BSKE) and All Succeeding BSKEs Thereafter";

**WHEREAS**, Section 252 of COMELEC Resolution No. 10924 mandates that any prohibited form of election propaganda shall be stopped, confiscated, removed, destroyed, or torn down by COOMELEC representatives, at the expense of the candidate for whose apparent benefit the prohibited election propaganda materials have been produced, displayed, and disseminated;

**WHEREAS**, Section 263, *supra*, states that the COMELEC hereby deputizes the LGUs, DILG and other government agencies to assist the Commission in removing and tearing down of unlawful propaganda materials without any partiality, to provide facilities and/or equipment necessary in tearing down of illegal propaganda materials and perform such other duties and functions as the Commission;

**WHEREAS**, Republic Act No. 3571 prohibits the cutting, destroying or injuring of planted or growing trees, flowering plants and shrubs or plants of scenic value along public roads, in plazas, parks, school premises or in any other public pleasure ground, which is reflected in Ordinance No. 8, s. 2023 "An Ordinance providing for the Establishment, Development, Conservation, and Maintenance of Municipal Parks and Green Spaces such as Public Parks, Plazas, and Open Spaces Devoted for Public Use, Regulating their Use, and Prescribing Penalties for Violations Thereof" enacted by the local government;

**WHEREAS**, DILG Memorandum Circular No. 2023-105 deputized the DILG and LGUs, among other government agencies, on the removal of unlawful election propaganda materials in line with the 2023 Synchronized Barangay and Sangguniang Kabataan Elections (BSKE), enjoining to designate through and Executive Order an LGU personnel who shall collaborate, coordinate, and assist the COMELEC/Election officer concerned in removing unlawful election propaganda/materials;

**NOW, THEREFORE**, I, Engr. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me and by expressed authority provided for by law to the Local Chief Executive, do hereby order and decree the following:

**LGU FOCAL PERSON.** Hereby designating JULIAN M. ILUMIN, as the LGU Focal Person to undertake the duties and responsibilities indicated herein.

**BARANGAY FOCAL PERSON.** All Punong Barangays are hereby instructed to designate Barangay Tanods as Focal Person to ensure compliance and effective implementation of this Order.

This Order shall take effect immediately.

Let copies hereof be furnished to all concerned for information, reference, and guidance.

**MEMORANDUM CIRCULAR NO. 2023-105**

**TO :** ALL PROVINCIAL GOVERNORS, CITY AND MUNICIPAL MAYORS, PUNONG BARANGAYS AND OTHER LOCAL OFFICIALS, DILG REGIONAL AND FIELD OFFICERS, AND OTHERS CONCERNED

**SUBJECT :** DEPUTATION OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) AND THE LOCAL GOVERNMENT UNITS (LGUs), AMONG OTHER GOVERNMENT AGENCIES, ON THE REMOVAL OF UNLAWFUL ELECTION PROPAGANDA MATERIALS IN LINE WITH THE 2023 SYNCHRONIZED BARANGAY AND SANGGUNIAN KABATAAN ELECTIONS (BSKE)

Republic Act (RA) No. 11935, otherwise known as **"AN ACT POSTPONING THE DECEMBER 2022 BARANGAY AND SANGGUNIAN KABATAAN ELECTIONS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9164, AS AMENDED, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES"**, mandates the conduct of the Synchronized BSKE on the last Monday of October 2023.

In this connection, the Supreme Court recognizes the legal practicality and necessity of proceeding with the conduct of the BSKE on the last Monday of October 2023<sup>1</sup> (October 30, 2023).

Also, Section 263 of the subject Resolution states that the COMELEC hereby deputizes the LGUs, DILG and other government agencies to assist the Commission in removing and tearing down of unlawful election propaganda materials without any partiality, to provide facilities and/or equipment necessary in tearing down of illegal propaganda materials and perform such other duties and functions as the Commission.

In this regard, all Local Chief Executives are enjoined to perform the following:

1. Provide COMELEC with the necessary equipment that will be used to remove and/or tear unlawful election propaganda.
2. Designate LGU personnel who shall assist the COMELEC/Election Officer concerned in removing unlawful election propaganda/materials. In the case of the barangay, the Punong Barangay may designate the Barangay Tanods who will provide the Commission with the necessary assistance.
3. Issue an Executive Order for the designation of the LGU personnel/Barangay Tanods and provide them with assistance that may be deemed necessary in the performance of their roles/functions.
4. Direct the designated LGU personnel/Barangay Tanods to collaborate and coordinate with the concerned Election Officer before the removal or tearing down of unlawful election propaganda.
5. Perform other functions, through the designated LGU personnel/Barangay Tanods, as may be prescribed by the Commission from time to time.

Further, all concerned are encouraged to immediately report to COMELEC any prohibited form of election propaganda for confiscation, removal destruction and/or prevention of the distribution of any illegal/unlawful propaganda materials.

All DILG Regional Directors and Field Officers are directed to cause the immediate and widest dissemination of this Circular within their respective jurisdiction.
