EXECUTIVE ORDER NO. 044, S-2023

PROVIDING FOR THE INTEGRATION OF BARANGAY CLEARANCE IN THE ISSUANCE OF BUSINESS PERMIT AND LOCATIONAL CLEARANCE IN THE MUNICIPALITY OF ASINGAN, PANGASINAN, AND FOR OTHER PURPOSE

WHEREAS, Republic Act NO. 11032 or the Ease of Doing Business and Efficient Delivery of Government Services (EODB-EGSD) Act of 218 mandates all government offices and agencies including local government units to promote simplification of transactions, inter-operability of government processes, and strengthened linkages and coordination among agencies;

WHEREAS, the DILG-DTI-DICT JMC No. 01, s. 2016 (Revised Standards in Processing Business Permits and Licenses in all Cities and Municipalities) and DILG-DPWH-DICT-DTI JMC No. 2018-01 (Guidelines in Streamlining the Processes for the Issuance of Building permits and Certificates of Occupancy) urges the streamlining of business and construction-related permits through the integration of the issuance of Barangay Clearance in the LGU Permitting Process;

WHEREAS, DILG MC No. 2019-177 (Guidelines in the Integration of the Issuance of Barangay Clearance in the Permitting Process of Cities and Municipalities) was issued to provide guidelines and standard processes in compliance to Section 11(f) of RA 11032 which states that "barangay clearances and permits related to doing business shall be applied, issued, and collected at the city/municipality in accordance with the prescribed processing time of this Act: *Provided*, That the share in the collections shall be remitted to the respective barangays", amending pertinent provisions of RA 7160, specifically Art. IV, Sec 152(c);

WHEREAS, there is a need to ensure that local business permitting process espouses "people-centered, clean, efficient, and effective governance" as reiterated in the Philippine Development Plan 2023-2028, which can be achieved through reduced documentary requirements, processing time, and signatories for transactions;

SECTION 1. NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me and by expressed authority provided for by law to the Local Chief Executive, do hereby order the Integration of Barangay Clearance in the Permitting Process of the Municipality of Asingan, Pangasinan.

SECTION 2. INTEGRATION OF BARANGAY CLEARANCE IN THE ISSUANCE OF BUSINESS PERMIT.

- New application of business permit with Certificate of Occupancy shall no longer require a barangay clearance if it was already provided by the business applicant to the Municipal Engineer Officer for securing Building Permit and Certificate of Occupancy.
- For new application which does not require Occupancy Permit, the BPLO shall notify the concerned barangay immediately for the issuance of barangay clearance for new application of Business Permit. The concerned barangay shall issue the Barangay Clearance for new application and a copy shall be submitted to the BPLO and shall be released to applicants together with the business permits.
- Barangay clearance shall be issued as a requirement prior the renewal of Business Permit, provided the business is compliant with applicable laws and regulatory bodies, occupational and safety standards to ensure public safety, health and welfare in all workplaces based on findings conducted by the municipality.

SECTION 3. INTEGRATION OF BARANGAY CLEARANCE IN THE ISSUANCE OF LOCATIONAL CLEARANCE FOR BUILDING PERMITS.

- The Zoning Officer shall notify concerned barangay for the issuance of Barangay Clearance for any application for Locational Clearance for Building Permit.

- b) The concerned barangay shall issue and submit the Barangay Clearance to the Zoning Officer who shall release the same to the applicant together with the Locational Clearance.

SECTION 4. PAYMENT FOR BARANGAY CLEARANCE FEE.

- a) The payment for the Barangay Clearance Fee is integrated in The Order of Payment (ToP) for Business Permit and Building Permit, together with the other authorized fees and charges.
- b) The authorized Municipal Treasurer shall collect payment and issue corresponding Official Receipt upon receipt of the payment from the applicant.

SECTION 5. RESPONSIBILITY OF THE BARANGAYS.

- a) The Sangguniang Barangay shall enact an ordinance relative to Barangay Clearance fees on business permit and locational clearance for building permit.
- b) The Sangguniang Barangay shall pass a resolution authorizing the Municipal Treasurer to collect fees for Barangay Clearance for Business Permit and locational clearance proposes.
- c) Comply with Sections 6.3.2.3 to 6.3.2.6 of DILG MC No. 2019-177 on the issuance of Barangay Clearance for new application of business permit, renewal, monitoring of business and construction activities, and issuance of barangay clearance.

SECTION 6. SUPPLEMENTARY CLAUSE. On matters not provided in this Order, any applicable laws and their corresponding implementing rules and regulations, executive orders, and relevant issuances therefore shall be applied in a supplemental manner.

SECTION 7. REPEALING CLAUSE. All orders, rules, regulations, and other related issuances inconsistent with or contrary to this Order are hereby repealed, amended, or modified accordingly. All other provisions of existing issuances which are not affected by this Order shall remain valid and in effect.

SECTION 8. SEPARABILITY CLAUSE. In the event any provision in this Order shall be declared invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired thereby.

SECTION 9. EFFECTIVITY. This Order shall take effect immediately.

Let copies hereof be furnished to all concerned for information, reference, and guidance.
