EXECUTIVE ORDER NO. 045, S-2024

ADOPTING THE DOH ADMINISTRATIVE ORDER NO. 2016-0014 ENTITLED "IMPLEMENTING GUIDELINES ON THE ORGANIZATION OF HEALTH CLUBS FOR PATIENTS WITH HYPERTENSION AND DIABETES IN HEALTH FACILITIES" IN THE MUNICIPALITY OF ASINGAN, PANGASINAN

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that the State shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, the Department of Health issued Administrative Order No. 2016-0014, which provides the "Implementing Guidelines on the Organization of Health Clubs for Patients with Hypertension and Diabetes in Health Facilities" to promote the prevention, early detection, and management of hypertension and diabetes at the community level through the establishment of health clubs in health facilities;

WHEREAS, the said guidelines were issued to strengthen the campaign against Non-Communicable Diseases at the primary health facilities specifically, the health centers and barangay health stations. These guidelines reiterate the policies and thrusts outlined in the "National Policy on Strengthening the Prevention and Control of Chronic Lifestyle Related Non-Communicable Diseases (NCD)" (DOH) AO 2011-003, and "Implementing Guidelines on the Institutionalization of Philippine Package of Essential NCD Interventions (PhilPEN) on the Integrated Management of Hypertension and Diabetes for Primary Health Care Facilities" DOH (AO 2012-0029);

WHEREAS, hypertension and diabetes have been identified as major public health concerns that contribute significantly to the burden of disease and healthcare costs in the Philippines, and it is imperative to strengthen health programs aimed at addressing these conditions;

WHEREAS, the Municipal Government of Asingan recognizes the essence of providing accessible healthcare services and implementing sustainable health programs that address the needs of individuals with chronic conditions such as hypertension and diabetes;

WHEREAS, there is a need to adopt the said guidelines in order for the municipality to properly implement and achieve its goal in creating and sustaining Hypertension-Diabetes Health Clubs;

NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, premises considered, by virtue of the powers vested in me and by expressed authority provided for by law to the Local Chief Executive, do hereby order the adoption of DOH Administrative Order No. 2016-0014 in the Municipality of Asingan with the following stipulations:

SECTION 1. PURPOSE. The Executive Order is issued to adopt and execute the "Implementing Guidelines on the Organization of Health Clubs for Patients with Hypertension and Diabetes in Health Facilities" as set forth by DOH Administrative Order No. 2016-0014 in the Municipality of Asingan;

SECTION 2. ESTABLISHMENT OF HEALTH CLUBS. The Municipal Health Office and barangay health stations in the Municipality of Asingan are hereby directed to establish and organize Health Clubs for patients with hypertension and diabetes. These shall be designed to render a comprehensive approach to disease prevention, early diagnosis, treatment and management of these chronic illnesses, pursuant to the guidelines expounded in the Administrative Order;

SECTION 3. IMPLEMENTATION AND MONITORING. The Municipal Health Office, in coordination with barangay health centers, shall oversee the proper implementation of this Executive Order and ensure that health clubs are duly organized, managed, and operational. The said office shall regularly make a report on the status of these health clubs and any challenges encountered in their implementation;

EXECUTIVE ORDER NO. 045, S-2024

ADOPTING THE DOH ADMINISTRATIVE ORDER NO. 2016-0014 ENTITLED "IMPLEMENTING GUIDELINES ON THE ORGANIZATION OF HEALTH CLUBS FOR PATIENTS WITH HYPERTENSION AND DIABETES IN HEALTH FACILITIES" IN THE MUNICIPALITY OF ASINGAN, PANGASINAN

SECTION 4. FUNDING. The necessary funds for the implementation of this Order, including the establishment of health clubs and provision of health facility activities, shall be sourced from available local funds or other funding sources that may be identified by the municipal government;

SECTION 5. REPEALING CLAUSE. All orders, rules, regulations, and other related issuances inconsistent with or contrary to this Order are hereby repealed, amended, or modified accordingly. All other provisions of existing issuances which are not affected by this Order shall remain valid and in effect;

SECTION 6. SEPARABILITY CLAUSE. In the event any provision in this Order shall be declared invalid, illegal or unenforceable, the validity, legality and enforceability of the remaining provisions shall not be affected or impaired thereby;

SECTION 7. EFFECTIVITY. This Order shall take effect immediately.
