EXECUTIVE ORDER NO. 058-B, S. 2022

ESTABLISHING THE ASINGAN LOCAL YOUTH DEVELOPMENT CENTER, PRESCRIBING GUIDELINES FOR ITS OPERATIONS, AND PROVIDING FUNDS THEREFOR

WHEREAS, the State recognizes the important role of the youth in nation-building and thus, promotes and protects their physical, moral, spiritual, intellectual and social well-being and encourages their active involvement and participation in public and civic affairs;

WHEREAS, Chapter IV of Republic Act 10742, otherwise known as the "Sangguniang Kabataan (SK) Reform Act of 2015" and its Implementing Rules and Regulations (IRR) and the DILG Memorandum Circular No. 2017-36 dated February 24, 2017 mandate the creation of a Local Youth Development Office (LYDO) in every province, city, and municipality;

WHEREAS, there is a need to establish a Local Youth Development Center managed by the Local Government Unit to serve as vital instrument for the literacy, values formation/restoration, and organization of youth in Asingan;

Section 1. NOW, THEREFORE, I, Engr. CARLOS F. LOPEZ, JR., Municipal Mayor of Asingan, Pangasinan, by virtue of the powers vested in me by law, do hereby order the establishment of the Asingan Youth Development Center located in People Empowerment Center (Danggay Building).

SECTION 2. COMPOSITION AND OPERATION. The Asingan Teen Center shall operate under the Local Youth Development Office to be headed and supervised by the designated Local Youth Development Officer, with the assistance of Sangguniang Kabataan, youth organizations, and volunteers.

The Center will be staffed by the Sangguniang Kabataan Chairpersons and officials from 21 constituent barangays in coordination with designated focal person of schools, civil society organizations, and volunteers.

SECTION 3. FUNCTIONS. The LYD Center shall serve the following purpose:

- Serve as venue for youth-led programs, projects, and activities relevant to youth participation in nation building and youth empowerment;
- Provide an avenue for youth participation in socio-civic, psycho-social, cultural, and moral activities initiated by the local government, NGAs, and CSOs; and
- Serve as venue for counseling and life skills/social development opportunities; and
- Provide a venue for leisure, recreation, and socialization among the youth.

SECTION 4. FUNDING. An allotted budget for the Teen Center shall be sourced from existing allocations of the Local Youth Development Office. A more detailed plan shall be drafted by LYDO for the inclusion in the annual budget.

SECTION 5. EFFECTIVITY. This Order shall take effect immediately.
